5. Revising Part 2 (Open Packaging Conventions)

Review of Murata’s Rewrite

Murata-san gave an overview of his rewrite (see <https://www.assembla.com/spaces/IS29500/documents>, file OfficeOpenXMLPart2-OpenPackagingConventionsMM0619.docx).

Members will each look at this in detail in preparation for the next teleconference.

Long-term Digital Signature

Murata-san summarized his mail from 2014-07-17, “XAdES in OPC: Further comments from Japan”:

I gave a report of the Prague meeting in the latest meeting of the Japanese SC34 mirror. Now, XAdES experts in Japan attended this meeting. They gave some comments (shown below). They plan to attend the Kyoto meeting.

- XAdES-C and XAdES-X-L are alternative choices. XAdES-C does not depend on XAdES-X-L, and XAdES-X-L does not depend on XAdES-C.
- XAdES-C and XAdES-X-L are intermediate forms rather than distributable forms.
- Among the profiles of XAdES, it is only XAdES-A that provides long-term digital signature.
- Although XAdES-A is not the only way for providing long-term digital signature, it is a standalone solution: no external data is required.
- Meanwhile, XAdES-X-L or XAdES-C can be combined with some external data for providing long-term digital signature. In other words, neither XAdES-X-L nor XAdES-C provides a complete solution.
- XAdES-X-L does not require the use of XAdES-C or XAdES-X.

Making a New Draft

There was a discussion about producing a new draft. Rex reported that WD0 was issued in May of 2013. It contained a number of tracked changes almost all of which applied to §4, “Terms and Definitions” and were a result of increased compliance with the ISO style guidelines. As it happens, we did review these changes in Berlin, in March of this year. From N 0278, “Minutes of the Berlin Meeting, 2014-03-04/06”

Terms and Definitions Review: We walked through the base draft of the OPC spec (N 0259) reviewing the tracked changes Rex made to the Terms and Definitions clause to comply with the ISO style guidelines. We accepted almost all the proposed changes except that,

- We added “behavior, application-defined” as an alternate term for “behavior, implementation-defined”.
- For “target part”, we removed the reference to the Target attribute of the schema, and used a definition analogous to that for “source part”.
- For “piece”, we adopted the stripped-down definition, but added a few words, resulting in “portion of a part used with interleaved ordering”.

We agreed that at the end of the next teleconference, we'd ask Rex to push out a new draft, WD1, which will include the edits adopted in Berlin, any further edits we agree on in that teleconference, and the latest version of Murata-san's rewrite paper. WD1 will then serve as the new base draft going into the Kyoto meeting.

It was noted that there likely would be more tweaking of the definitions for existing terms as well as the addition of some new ones to accommodate new text regarding digital signatures.
